1. General

The present tender is being invited for SECURITY SERVICES AT IHM LUCKNOW, SECTOR G ALIGANJ, UTTAR PRADESH-226024.

2. Eligible Bidders

Contractors holding valid labour license under Contract Labour (Regulation & Abolition), Act 1970, registered with Service Tax, ESIC and EPF authorities and who have successfully carried out at least one work of similar nature amounting to Rs. 33,00,000/-or above or two works of Rs. 21,00,000/-or above each or three contracts each amounting to Rs. 16,80,000/-or above in a single contract in a single year during the last five years in Institutes of Govt. / Semi Govt. / Autonomous Bodies / Public Sector Undertakings Companies are eligible to apply. 
